

Announcement of Periodic Review: Moody's announces completion of a periodic review of ratings of Bulgarian Energy Holding EAD

Frankfurt am Main, April 02, 2019 -- Moody's Investors Service ("Moody's") has completed a periodic review of the ratings of Bulgarian Energy Holding EAD and other ratings that are associated with the same analytical unit. The review was conducted through a portfolio review in which Moody's reassessed the appropriateness of the ratings in the context of the relevant principal methodology(ies), recent developments, and a comparison of the financial and operating profile to similarly rated peers. The review did not involve a rating committee. Since 1 January 2019, Moody's practice has been to issue a press release following each periodic review to announce its completion.

This publication does not announce a credit rating action and is not an indication of whether or not a credit rating action is likely in the near future. Credit ratings and outlook/review status cannot be changed in a portfolio review and hence are not impacted by this announcement. Key rating considerations are summarized below.

Bulgarian Energy Holding (BEH)'s Ba1 corporate family rating reflects (1) BEH's improved financial flexibility supported by deficit reduction measures and a reduction in public mandate activities; (2) the group's competitive position in electricity generation; and (3) its ownership of Bulgaria's strategic energy infrastructure.

However, the rating also reflects (1) the volatile earnings profile of the group, due to an unsettled regulatory regime, which limits cash flow visibility; (2) a constantly evolving electricity market, mostly as a result of liberalisation; and (3) weak liquidity management, although BEH currently has a strong liquidity position.

BEH's rating incorporates its 100% ownership of the Government of Bulgaria (Baa2 stable). Accordingly, and based on Moody's view of high default dependence and high support in case of financial distress, BEH's rating incorporates three notches of uplift from its standalone credit quality or baseline credit assessment of b1.

This document summarizes Moody's view as of the publication date and will not be updated until the next periodic review announcement, which will incorporate material changes in credit circumstances (if any) during the intervening period.
